

## TERMS AND CONDITIONS FOR NOMINATING PROJECTS FOR THE EVENT "WHAT HAS THE EUROPEAN MONEY DONE FOR YOU, FOR YOUR PLACE?"

- 1. Organisers of the contest for the best project "WHAT HAS THE EUROPEAN MONEY DONE FOR YOU, FOR YOUR PLACE?" shall be the Government Office for Development and European Cohesion Policy and the Ministry of Agriculture and the Environment.
- 2. Information about the contest and terms and conditions to enter the contest "What has Europe done for you" are available at www.eu-skladi.si/en and http://www.program-podezelja.si/en/.
- 3. The contestants shall enter the contest by submitting their nominations to the e-mail address info.svrk@gov.si between 5 August 2014 and 12 September 2014. The nominations shall refer to the projects that were implemented in Slovenia and received support from the European Regional Development Fund, the Cohesion Fund, the European Social Fund, the European Agricultural Fund for Rural Development and/or the European Fisheries Fund. The project can be financed by several of the above Funds at a time.
- 4. The participants shall add the following information to the nominated project:
  - which project is being nominated,
  - the place, where the nominated project was implemented,
  - a brief project description (a maximum of three sentences) explaining why the contestants chose the nominated project or how the nominated project made a difference in their life or in their community (how the project improved the quality of their life or of their community).

The contestants shall add the following contact information to the nomination: name and last name, e-mail address and phone number. The information shall be used if the contestants win a prize. Each contestant shall nominate a maximum of three projects.

- 5. A panel of judges representing the Government Office for Development and European Cohesion Policy (Nataša Rojšek, head of the judge panel, Nataša Kogej, member of the judge panel and Gregor Čufer, member of the judge panel) and the Ministry of Agriculture and the Environment (Martina Štupar and Simona Dolinšek) shall screen the nominations and assess whether they comply with the terms and conditions and shall randomly draw 25 projects to enter the photography exhibition 2. Short videos shall be made about these projects.
- 6. Visitors of the exhibition shall vote for the best project among exhibited projects. At least one of the visitors to cast their vote shall receive a prize.
- 7. Prize winners shall be selected by the judge panel in a random drawing from among all the contestants who submitted a nomination. One of the voters who voted for the winning project and the contestant who nominated the winning project shall also receive a prize. The winning project shall be the project receiving most "best project" votes by the visitors of the exhibition.
- 8. Entrants to this contest and/or winner shall be a natural or a legal person with a permanent residence in a Member State of the European Union. By entering the contest, the contestants and/or the winners agree with the terms and conditions, and, should they receive a prize, agree they shall provide any personal information necessary to report the winning in the personal income tax and pay personal income tax or to receive the prize.
- 9. Entrants and/or winners allow to have their name and last name and the description of the nominated projects published at the following websites: <a href="www.eu-skladi.si/en">www.eu-skladi.si/en</a> and <a href="http://www.program-podezelja.si/en/">http://www.program-podezelja.si/en/</a>, <a href="www.facebook.com/EUskladi">www.facebook.com/EUskladi</a>.
- 10. Prizes: weekend break for two persons in the Balnea Hotel, Dolenjske Toplice Thermal Spa; Adrenaline Park tickets (Otočec Hotels); day-tickets for swimming pools at the Dolenjske Toplice or Šmarješke Toplice Thermal Spas; practical and other prizes.
- 11. Winners shall be listed at the websites <a href="www.eu-skladi.si/en">www.eu-skladi.si/en</a> and <a href="http://www.program-podezelja.si/en/">http://www.program-podezelja.si/en/</a>.
- 12. Prizes are non-transferrable and there is no cash alternative. The winner of the first prize shall present an identification document while claiming the prize in person at the registered office of the organiser. Underage winners shall collect the prize only upon submission of a written consent of their parents or guardian. Practical prizes shall be sent by post. Each entrant may receive only one prize (first prize).



- 13. Prize winners shall submit all personal information to the organiser upon request. The information shall be used for reporting or paying personal tax income or for collecting the prize.
- 14. The winners agree that their personal data are used for the purpose of personal income tax prepayment by the organiser and for promotion-related activities of the Government Office for Development and European Cohesion Policy and the Ministry of Agriculture and the Environment in line with the Personal Income Tax Act. The government office and the ministry undertake to keep and protect the data in line with the Personal Data Protection Act.
- 15. Personal income tax prepayment shall be assessed and paid by the organiser in the amount relative to the prize amount. Other potential tax burden associated with receiving the prize shall be borne by the entrants themselves.
- 16. Complaints shall be addressed by the organisers. Should complaints be deemed well-founded, the organisers undertake to solve them in the shortest possible time and notify thereof any participants or other entrants.
- 17. Employees of the Government Office for Development and European Cohesion Policy and of the Ministry of Agriculture and the Environment are not eligible to participate in the contest.
